APPLICATION FOR VENDOR'S LICENSE

Dear Prospective Vendor:

This agreement is entered into by: _____

and Theta Chi Psi Fraternity, Inc. The holder, listed above is permitted to sell goods or services as stated in this application, at all Fraternity sponsored activities and hereby agrees to adhere to the Rules and Restrictions described in same for five (5) Fraternity years from date of issue.

In addition, to the conditions set forth in the License, the parties agree as follows:

1. That the Vendor shall pay to the Fraternity, upon execution of the Agreement, the amount listed below which constitutes a non-refundable payment on account of the License fee here in.
 - a. **\$0** – Original Vendor License Application Fee
 - b. **\$0** – Vendor License Renewal Fee
2. Vendor shall submit a detailed list of all merchandise to be sold which displays the name, letters, insignia, etc. of Theta Chi Psi Fraternity, Inc.
3. Theta Chi Psi Vendor's License **must be displayed by Vendor at all Theta events.**
4. Vendor shall not sublet booth(s).
5. An Additional fee may be required to be paid as determined by the Grand Master and or Grand Executive Counsel to set up at international or Regional meetings respectively.
6. It is expressly understood and agreed by Vendor that Theta Chi Psi Fraternity, Inc., its Executive Board, Directors, members, sponsors, employees, or agents, shall not be liable for loss, theft, or damage to goods or properties of Vendors.

THETA CHI PSI FRATERNITY, INC. reserves the right to cancel the Vendor's License upon failure of Vendor to comply with any condition of said License or any provision of this agreement but said cancellation shall not relieve Vendor of its obligation to the License Fee as provided for herein.

VENDOR RESTRICTIONS

The following guidelines must be adhered to by all vendors. Any vendor doing any of the following will be immediately escorted off the premises by security and their license will be REVOKED and refund will be issued.

Please note, we recommend **only items using the official colors: Orange, Maize, black and white.**

YOU CANNOT:

1. Manufacture, reproduce or sell any facsimile or representation of the Theta Shield without permission from the current Grandmaster or Current Executive Director. (This is the official "Badge" of the Fraternity, which is restricted to its use as a Badge, and prohibited for reproduction without approval.)
2. Sell undergarments of any kind with the letters or symbols of Theta Chi Psi in places that are easily dirtied or the seat of such garments.
3. We ask that you be cautious in your production and sale of merchandise produced on backgrounds other than the official colors.
4. Sell items bearing other companies name/emblem/symbols that are not properly registered or authorized by appropriate company officials. [When vending at any Theta Chi Psi event.]
5. Sell in conjunction with Theta paraphernalia, any items that have been reproduced illegally (Boot-Leg Cd's, DVD's, Video Tapes, etc.); In which you do not have appropriate written permission to sell.
